Collection Policies, Notifications

Board wanted a letter to go out to the homeowners about the collection policies; The following was in put into the letter

All Assessments are due on the first of each month and considered late after the fifteenth of each month. A late fee of \$35:00 is charged to the account. Approximately 30 days after the missed payment, a late account will be receive a letter indicating that they are late one month, and that the next monthly assessment is also due. A \$35 Charge is assessed to the homeowner for this letter. Then at 45 days late there is a second late fee of \$35 and a letter that is sent as a second reminder that you owe two months assessments, plus two late fees, plus letter fees. There is a \$50 charge for this second letter. If you have not made arrangements to pay what is owed by 60 days, the delinquent account is turned over to the association attorney. The attorney will do an ownership search and send you a letter giving you a final 30 days to pay your account, after which a court date will be set. You will be assessed an additional \$160:00 for this service. This total of \$350 is additional Expenses up to this point-plus the unpaid assessment.
